The City of Lancaster, Texas has received your public information request for Incident report 11-003276, dated February 9, 2015.

The information you requested contains one or more of the following types of information, which are excepted from disclosure under the Texas Public Information Act ("PIA"):

- A direct deposit authorization form under Government Code section 552.101 in conjunction with the common-law right to privacy;
- A Form I-9 and attachments under Government Code section 552.101 in conjunction with section 1324a of title 8 of the United States Code;
- W-2 and W-4 forms under Government Code section 552.101 in conjunction with section 6103(a) of title 26 of the United States Code;
- A certified agenda and tape of a closed meeting under Government Code section 552.101 in conjunction with section 551.104 of the Government Code;
- A fingerprint under Government Code section 552.101 in conjunction with section 560.003 of the Government Code;
- L-2 and L-3 declarations under Government Code section 552.101 in conjunction with section 1701.306 of the Occupations Code;
- A motor vehicle operator's or driver's license or permit issued by an agency of this state or another state or country; a motor vehicle title or registration issued by an agency of this state or another state or country; a personal identification document issued by an agency of this state or another state or country or a local agency authorized to issue an identification document {driver's license number, vehicle identification number, the type/class of license, copy of the license and license plate number} under Government Code section 552.130;
- A credit card, debit card, charge card, or access device number that is collected, assembled, or maintained by or for a governmental body, insurance policy number, bank account number, and bank routing number under Government Code section 552.136;
- An e-mail address of a member of the public under Government Code section 552.137; or,
- A Form DD-214 or other military discharge record that is first recorded or first comes into the possession of a governmental body on or after September 1, 2003 under Government Code section 552.140

Normally, we must request a ruling from the Texas Attorney General before we can withhold any of the above-referenced information you requested. However, Attorney General Open Records Decision Number 684 (2009) and Section 552.301(a) of the Government Code permits us to withhold this specific information without requesting a ruling from the attorney general. Therefore, we have removed this information from the enclosed information we are providing to you.

You have the right to appeal our decision to withhold this information from you. Instructions for appeal are at the end of this letter. If you do not want to appeal, you do not need to do anything else. Please note that we are only withholding the specific categories of information that may be withheld under Attorney General Open Records Decision Number 684 (2009). We will process the rest of your request for information in accordance with the terms of the Public Information Act.

How to appeal the withholding of information under Attorney General Open Records Decision Number 684 (2009)

If you wish to appeal the withholding of information discussed on the previous page, you must send the following to the attorney general:

- 1) a signed, written statement indicating your wish to appeal the withholding of information;
- 2) the name of the governmental body that withheld information from you;
- 3) the date you made your original request for information; and
- 4) a copy of your original request for information, or if you are unable to provide a copy, a description of your original request for information.

You may also submit written comments stating why you think the information should be released to you, but you are not required to do so.

Send your appeal by mail to the attorney general at:

Within forty-five business days after receiving all of the above-listed items necessary to file your appeal, the attorney general will issue a written ruling on the matter. You will receive a copy of this ruling in the mail.

NARRATIVE

On 07-11-2011, Officer Johnson was dispatched to the 100 block of N interstate 35E in response to an unknown disturbance.

THE INFORMATION BELOW IS CONFIDENTIAL - FOR USE BY AUTHORIZED PERSONNEL ONLY

On 07-11-2011 at 0608 hours, Officer Johnson #3637, was dispatched to the parking lot of Walmart, located at 150 N IH35E, in response to an unknown disturbance. Prior to arrival, dispatch advised that an unknown person reported seeing a B/F being dragged from one vehicle to another vehicle by a B/M. The unknown person stated the vehicle she was dragged from was still in the parking lot with the door open. Dispatch advised that the vehicle was a white 2011 Mercedes Benz, bearing TX license plate

The vehicle was registered to Desmond Bryant out of Desoto, TX.

Upon arrival, Officer Johnson made contact with Ogunoye, Olanrewaju B/M, the Yale security guard in the Walmart parking lot, who stated an unknown person told him that there was a disturbance in the parking lot involving a B/M and a B/F, where she was pulled out of a vehicle. Ogunoye stated when he arrived on the scene, no one was there except the white Mercedes Benz with the door open and a child's toy on the ground. Ogunoye stated a few minutes later, a black Cadillac Escalade, registered to Desmond Bryant, bearing TX license plate showed up with two B/M and parked next to the white Mercedes. Ogunoye stated a Desoto officer, Chaney, stopped in the parking lot and contacted this agency.

Officer Johnson made contact with the two males that were in the Cadillac Escalade. King, Carl B/M 07-27-89 out of Pollock, TX and Mitchell, Christopher B/M 10-29-74 out of Alto, TX. Upon speaking with them seperately, both had the same story where they received a call from Nash, Ilyne, asking them to pick up her white Mercedes in the parking lot of Walmart. King and Mitchell were at a friend's house on Wintergreen Rd in Desoto, TX.

While speaking to King and Mitchell, a white Bentley, bearing TX license plate comes into the parking lot. Inside the vehicle is the victim, Nash, Ilyne B/F 07-26-87 and Desmond Bryant. Officer Johnson made contact with Nash who stated she was in the parking lot with Alex Penson B/M, unknown date of birth, and had an argument with him. She got into the vehicle with him and left her vehicle in the parking lot. Nash stated she contacted King to have him pick up her vehicle. Nash stated she was not assaulted or injured in any way and that it was just an argument with Penson. Nash stated she was dropped off at a friend's house, unknown address, and she contacted Bryant to pick her up. Nash stated she spoke to King, who advised her to come back to the parking lot.

Officer Johnson made contact with Bryant, Desmond B/M 11-4-88 who stated Nash contacted him and stated she had an argument with someone. Bryant stated he went to pick her up in Desoto and came with her to the parking lot for support. After speaking with all parties involved, it was determined that there was no offense. All parties were advised they were free to go.
